TRENDS IN KANSAS CITY



For the past five years, nearly half of KC's homeless have been families.



STABILIZING, REHOUSING AND EMPOWERING FAMILIES

- ➔ **Stabilizing:** Rapid Rehousing evidence-based programs quickly provide shelter and stability for children and parents. Case Management and advocacy for the adults and children help families stabilize quickly and focus on their future.
- ➔ **Rehousing:** Housing Coordination assists families by addressing housing debt and affordability. Families can secure permanent housing and participate in Aftercare Services to ensure retention.
- ➔ **Empowering:** Core competency programs include employment services, budgeting, mental wellness services and healthy lifestyles for adults. Academic support, resiliency classes and nutritional life skills for children help the entire family work to break the cycle of homelessness.

IMPACT OF OUR PROGRAM

We serve nearly 450 people in 125 families a year with most being children.

From 2012–2016, 84% of families remained housed and self-sufficient based on a five-year retention study of all program graduates.
