EACH FAMILY RECEIVES A FULLY FURNISHED ON-CAMPUS APARTMENT AT NO COST WITH UTILITIES PAID UNTIL THEY TRANSITION INTO PERMANENT HOUSING. FAMILIES WORK WITH FINANCIAL COACHES, SAVE MONEY, AND REDUCE DEBT TO STABILIZE FOR THEIR TRANSITION. ALL CHILDREN PARTICIPATE IN RESILIENCY CLASSES AND RECEIVE ACADEMIC SUPPORT AND GROUP ENGAGEMENT ACTIVITIES.
